



Polish Open 2012

01/02/2012 - 28/02/2012

1. ORGANIZING AUTHORITY

Polish Virtual Sailing Club (www.pol-vsc.org) is the Organizing Authority for the regatta.

2. REGATTA VENUE

- 2.1 Regatta will be conducted using Virtual Skipper 5 simulation software.
- 2.2 Regatta will take place on servers hosted by organizing authority (or designated person).
- 2.3 Server names will contain the text: 'PO 2012' .

3. REGATTA SCHEDULE

- 3.1 There will be 3 qualification series and 3 final series, which will be held on Tuesdays and Wednesdays.
- 3.2 Each series consist of 3 races.
- 3.3 Preparatory signal for the first race: 21:30 CET (GMT+1).
- 3.4 The following races will be started just after finishing of the previous one (regardless of the time stated in the schedule).
- 3.5 Qualification series will be held on: 01/02/2011, 08/02/2012, 15/02/2012
- 3.6 Final series will be held on: 21/02/2011, 22/02/2012, 28/02/2012

4. YACHTS ELIGIBLE FOR REGATTA

Each user registered on POL-VSC forum and signed on Polish Open 2012 is eligible for the regatta.

5. SIGNUPS

- 5.1 Regatta sign-ups will be accepted till 31/01/2012 24:00 CET (GMT+1) .
- 5.2 In order to sign up for the regatta one must use Polish Open 2012 sign-up form on POL-VSC website (http://pol-vsc/results_round.php?id=500).

7. RULES

- 7.1 The following rules will apply in the regatta:
 - a. Racing Rules of Sailing : ISAF 2009-2012

b. Notice of race for Polish Open 2012
c. Polish Open 2012 Sailing Instruction

7.2 In case of conflict within these documents, rules stated in Sailing Instruction will prevail (English version).

7.3 Nadeo umpire will be used, however Pen Cancellation rule with protest procedure as stated in Sailing Instruction will apply (see PO 2012 SI for details).

8. YACHTS AND SAILS

8.1 Regatta will be conducted on ACC boat (**Virtual Skipper 5**)

8.2 The use of spinnaker after preparatory signal until the yacht has started is forbidden.

9. REGATTA FORMULA

9.1 Qualification round and final round shall take place.

9.2 For the qualification round, the following rules will apply:

9.2.1 Three (3) qualification series will be held, three (3) races of each series.

9.2.2 If more than 20 yachts will sign up for the regatta, they shall be divided into groups.

9.2.3 Group quantity cannot exceed 20 yachts.

9.2.4 In the first series, the groups will be created randomly.

9.2.5 In the following series, the groups will further be assembled considering PO 2012 ranking and based on following schema:

Group A:

1, 4, 5, 8, 9, 12, etc. ...

Group B:

2, 3, 6, 7, 10, 11, etc. ...

The schema mentioned above will be used for assignment to more groups.

9.3 Yacht distribution among groups will be published on start lists in cups section for Polish Open 2012 on Polish Virtual Sailing Club website.

9.4 For the final round, the following rules will apply:

9.4.1 The best 20 yachts from qualification round will advance to the final round.

9.4.2 Three (3) final series will be held, three (3) races each series.

10. SCORING

10.1 Low Point System will be used for scoring.

10.2 Two worst results in qualification round will be discarded.

10.2 In the final round, one (1) worst result among first 8 races will be discarded.

10.3 The result for the last final race will be doubled and can not be discarded.

10.3 DNE and/or DGM results can not be discarded.

10.4 The final ranking is a sum of qualification and final round results.

11. COURSES

11.1 Courses will be provided by organizing authority.

11.2 First leg will be upwind.

11.3 Courses will be published by organizing authority not later than the regatta starting day.

12. MEDIA RIGHTS

By participating to a race (in particular by showing on a start line) the participant allows for free non-commercial usage of his/her individual image in pictures, video and other publications concerning regatta.

13. DISCLAIMER OF LIABILITY

13.1 Participants to the regatta enter to the regatta on their own risk entirely. By showing on a start line the participant accepts Polish Open 2012 sailing rules.

13.2 No action performed or not performed by organizing authority will dismiss any liability of a participant for any damage caused by the participant or his yacht in participation in the regatta.
